# GRANT AWARDS

BTC's Machining program has received a five-year Aerospace High Demand FTEs grant award from the State Board of Community and Technical Colleges. The program will receive \$104,000 per year to expand enrollment through a gradual shift to competency-based instruction. These funds will support instructional design and curriculum development efforts, along with related supplies.

Fisheries & Aquaculture Sciences program faculty are participating in two new grant projects that will benefit program students. The first is a Career Connect Washington grant that will help partners build an advanced high school aquaculture course that is aligned to BTC's program. High school students taking this class will be able to earn dual credit. The second is a Washington Sea Grant through the University of Washington, which is a collaborative partnership to address mass mortalities in oyster aquaculture. This grant will support the Fisheries & Aquaculture Sciences program's involvement in a shellfish experiment (including paying for student workers and project supplies), along with internships and field trips.

# TRIO

TRIO, a program funded through grants, caters to students meeting specific criteria: those who are the first in their families to pursue college, hail from low-income backgrounds, or have a disability.

TRIO provides students with tailored academic and career coaching, round-the-clock tutoring, peer mentoring, assistance in financial literacy and accessing financial aid, and ongoing guidance throughout their college journey. Additionally, the program hosts skill-building workshops and opportunities for leadership development.

This autumn, TRIO students actively participated in leadership and community service projects. In November, we volunteered at the YWCA, aiding families transitioning into a new apartment. During our Dec. 1 leadership seminar, we met the outgoing and incoming Whatcom County Auditor and toured the Elections Center to learn how ballots are processed.









# PROCURE TO PAY QUESTION OF THE MONTH

**December Question**: I was doing my P-Card review and I see a charge I didn't make. What do I do?

**Answer:** This is a great question and one that I really dislike having to answer. Many of us do a majority of our purchasing from online vendors like Amazon. Unfortunately, online credit card fraud is rampant and only getting worse; there were close to \$8 billion in losses in 2021, up \$2 billion from 2019.

The first thing to do is call the number on the back of your card. Call Customer Service at (800) 344-5696 and let them know you see charges that are not your own. They will typically cancel your card and reissue you a new one with a new number.

Next, email me at <a href="mnelson@btc.edu">mnelson@btc.edu</a> and let me know about the issue. In US Bank, do not mark the charge(s) as reviewed and add a comment that this is a fraudulent charge.

I will receive your replacement card and process it. Once done, I'll email or call you to make arrangements to get you your new card. Your card will already be associated with your account, but if someone assists you in reallocating expenses, I will need to make sure they also have access.

The bank will send you a form to fill it out via postal mail. Contact me if you have any questions when you get the form. Otherwise, fill it out and sign it, scan a copy to me, and then send it back to the bank via fax or mail by the due date.

As vigilant as we are with our credit card information, this type of identity theft can happen to any of us. It helps to practice good credit card hygiene: secure your card in a locked drawer or in your wallet/purse; never fill out online forms with card information that are not secure pay portals or send your full card number via email; do not save your card information on websites wherever possible; and stay away from purchasing on sketchy-looking websites. When in doubt, reach out!
