Dr. Kimberly Perry, our past president, has officially retired and is now starting her new adventure on her farm in Georgia — and with that brings the good tidings of our new interim president, who many of us already know, but who in fact has a very interesting back story — read on about Interim President Walter Hudsick in his own words.

When I became VPAASL at BTC, I told people that I expected it to be my last, best job. I am delighted to be shown wrong and happy that the Board of Trustees has had the confidence to ask me to serve as Interim President.

My work experience has included stints in technical positions in the workers' compensation insurance industry, as a small business owner, as a commissioned law enforcement officer, in library service, and as a community advocate. I have worked for city, county, and state agencies as well as in the private sector.



Latterly, I have found my focus and have been involved in higher education for the past 25 years or so. My first position in the field was as Director of Safety and Security at Clark College in southwest Washington. It was at this job that that I found my calling in the community and technical college system and in our mission to change the trajectory of people's lives. After finishing the appropriate education, I transitioned into the instructional side of higher ed as Director of the Writing Center at North Seattle College. I moved from the center into the classroom as a "freeway flyer" -- an adjunct faculty member at several schools in the Puget Sound area. I kept this up until I was offered a tenure track position at Cascadia College, where I did obtain tenure and also became Dean of Student Learning. I moved a little closer to Canada to become Dean of Professional/ Technical Programs and later to serve as Vice President of Academic Affairs & Student Learning here at BTC.

I first attended college as traditional student in the 1970s and finally completed my undergraduate education in Criminal Justice and Philosophy as an adult learner 27 years later. Perhaps to make up for lost time, I managed to earn my master's degree in Rhetoric in just 11 months.

While I grew up and came of age in New York City, I first moved to Portland, Oregon in 1978 and consider the Pacific Northwest my home (although I did live for a brief time in Charlotte, North Carolina). I now live in Fairhaven, adjacent to a greenbelt, overlooking Bellingham Bay, the train station, and the Alaska Ferry Terminal, a five-minute walk from Marine Park in one direction and Fairhaven Village Green in the other – overall, a pretty idyllic setting. I share my life with Coco (aka Wonder Wife) and our fur-kid, Selkie the cat. If I am in motion, it is likely walking the neighborhoods or riding a bike; if I am stationary, it is likely with the New York Times crossword or a graphic novel.

I am looking forward to my new position as Interim President and the chance to work across campus with the all the people who make BTC the innovative, service-oriented, student-centered institution that it is.

### PAYROLL CHANGES COMING TO BTC

As we prepare for a new payroll system to be implemented in the fall, the following changes are being made.

Effective April 1, 2021, all adjunct faculty, temporary and student employees will be paid twice a month on the 10th and 25t. For those affected, the first payment will begin on April 25, instead of May 10.

Timesheets will need to be submitted to your supervisor twice a month, by the 15th and last workday. Time worked between the 1-15 is paid on the 25; Time worked between the 16-31 is paid on the 10th of the ensuing month. Late timesheets will be processed in the following pay period.

Supervisors should submit approved timesheets to payroll@btc.edu by the 15th and last day of the month each month.

For those still receiving paper checks, we are requesting you complete a Direct Deposit form. Email <u>payroll@btc.edu</u> if you need a form for any question.
