Once funds are available they will be released to you no sooner than the start of any given quarter, via your BankMobile. **The student is responsible for understanding all rules and regulations provided by the lender.**

The loan amount(s) must fit within your Cost of Attendance for each quarter. We may not be able to approve your full loan request depending on other sources of funding. Changes to this request must be made by completing a new form before your funds have released.
