## Reinstatement of Eligibility

- Students have the right to petition for a change in financial aid eligibility status if their failure to maintain satisfactory progress was due to extraordinary circumstances (death in the family, severe illness, house fire, etc.).
- Students who have already petitioned and received reinstatement may not be approved again for the same reason.
- Students who are not approved may regain Satisfactory Academic Progress by completing a quarter without the assistance of federal or state aid.
- A complete copy of the Satisfactory Academic Progress policy is available in the Student Financial Aid Handbook, located in your Financial Aid Portal or on the BTC Student Financial Resources webpage.
- **The decision of your petition is final.**

## Petition Requirements

Submit the following to the BTC Student Financial Resources Office (include ALL of the following):

1. **This form**, completed and signed by the student
2. **A written**, personal statement detailing the following (use page 2 or attach additional pages):
  - A) What were the unusual circumstances leading to unsatisfactory academic progress?
  - B) What is your plan to improve the situation and to ensure academic success?
3. **Supporting documentation** from a doctor or instructor (if applicable).
