## **Institutional Effectiveness Updates**

#### **Strategic Priorities**

BTC identified 12 strategic priorities to guide our work across the 2015–16 and 2016–17 academic years. The Board of Trustees approved these priorities on Feb. 18, 2016.

Sample priorities include:

- Aligning student support services across campus departments
- Providing more and earlier assistance to students who may be struggling
- Creating new, flexible educational pathways and transfer options for students
- Developing and implementing a campus-wide graduation plan
- Providing professional development opportunities to all employees

#### **Grant Development**

Grant development at BTC focuses on supporting the college's mission, goals, and strategic priorities. During the 2015-16 year:

- BTC managed or participated in over 20 grant projects valued at nearly \$11 million (totaling \$2.4 million in funding for the 2015-16 year).
- The college received **eight new competitive grant awards**—including the college's first TRIO Student Support Services grant and the nation's only Title III Cooperative Arrangement Development grant—valued at **\$4.6 million** (totaling \$625,000 in funding for the 2015-16 year).

#### **Accreditation**

BTC is accredited by the Northwest Commission on Colleges and Universities (NWCCU), an institutional accrediting body recognized by the Council for Higher Education Accreditation and the United States Department of Education. Accreditation by NWCCU indicates that the college meets or exceeds criteria for institutional quality and has the necessary resources to achieve its stated purposes. During the 2015-16 year:

- NWCCU reaffirmed BTC's accreditation status based on the college's Year One Mission and Core Themes Report.
- NWCCU approved BTC to offer its first ever Bachelor of Applied Science (BAS) degree in Operations Management.

BTC continues to maintain a robust mix of revenue sources with a continuing emphasis on securing grant funding. BTC's expenditures mix reflects a strong commitment to instruction and student support service.

The Council for Advancement & Support of Education (CASE) is a professional association serving educational institutions and the advancement professionals who work on their behalf.

BTC is one of the nation's top fundraising community & technical colleges for its size.



Based on money raised by the school over the last 5 years, CASE found that BTC is among the top 25 community & technical colleges with an FTE enrollment of fewer than 2,000 students.



BTC is **1 of 3** technical colleges on the list of recognized two-year colleges, and it's in the **top 10**% of similar-sized colleges for fundraising.

Every student deserves the opportunity to succeed, and this effort begins through BTC's campus-wide initiatives and support from key elements of our Student Services team. # Here are some highlights from our Student Services departments:

#### **Admissions**

Participation rates for the new student orientation increased by 66% compared to the previous year; the one-year retention rate for those attending orientation was 87%.

The Customer Relationship Management system helped BTC reach out, via Hobsons Connect, to more than **27,238 email addresses** and make over **6,500 phone calls.** 

Three major programs — BCIS, CNET, and Engineering — changed to an **open-enrollment entry**, eliminating these programs' waitlists and removing barriers for new students.

#### Over 7,000 contacts were made in outreach efforts.

We're starting the college conversation earlier and increasing middle school interest, with four middle school visits that brought over 400 students on campus.

BTC held two **Energy Industry Careers Nights**, geared towards veterans, women interested in non-traditional fields, and underrepresented populations. BTC programs participated with presentations and program tours.

Connecting with high school students and helping them envision themselves at BTC was a strong focus, as eight industry tours were arranged with our industry partners to introduce high schoolers to the careers available to them with a BTC degree. **Tour Day, Try-A-Trade, and BTC-Bound Day** brought students on campus to experience some facets of campus life for themselves.

**Multiple Measures** for assessment of math and English was designed, allowing alternative assessments to reduce barriers and provide equity for students entering BTC.

#### **TRIO & STAR**

BTC implemented its first grant-funded TRIO and STAR programs, which provide intensive support to students from low-income and first-generation backgrounds to improve their chances of success.

There are **over 70 students currently enrolled each** of the TRIO and STAR programs. Two TRIO students have already graduated.







# Advising, Student Life & Accessibility Resources

With the hiring of a full-time student life coordinator in spring 2016, the college will be **expanding student life**, with more **leadership opportunities**, **club activities** and **social programs for our students**.

The Academic and Career Advisors served **877 students** in Advising & Registration Sessions for the 2015-2016 academic year. There was an **85%** participation rate from students who had signed up to attend the sessions.

Advising and Career Services expanded **BTC's Career Fair** offerings from two to three fairs this spring.

Accessibility Resources served **290** total students in the 2015-16 academic year.

The AR Leadership team, in collaboration with members of Phi Theta Kappa and the BTC Student Government, established a **Community Food Garden** for students who struggle with food insecurities. The garden supplements the already established BTC Food Pantry.

### **Multicultural & Diversity**

The Multicultural and Diversity Committee hosted the **Lummi Blackhawk Singers** at BTC in Winter Quarter for a moving demonstration of traditional dance, music, and stories of the Lummi people.

Staff hosted a **Veteran's Day** lunch and celebration of BTC veterans last November, with Lourdes E. 'Alfie' Alvarado-Ramos, Director of the Washington State Department of Veterans Affairs, as the guest speaker. Also in attendance were several local law enforcement officials, including Lynden Police Chief Jack Foster, Bellingham Police Chief Cliff Cook, Sumas Police Chief Chris Haugen, Everson Police Chief Dan McFee, and Whatcom County Sheriff Bill Elfo.

Films from the 2016 **Human Rights Film Festival** were presented on campus in February.

**The Student Veterans of America BTC Chapter** attended the 1st Annual SVA Regional Summit at Washington State University in April.

Motivational speaker **Steve Ferreira** spoke about disability awareness and living life to the fullest in June.



### Registration

In collaboration with IT, Registration developed and implemented the **FERPA** (Privacy Act) training PowerPoint with an online quiz.

In collaboration with Instruction, Registration completed the online **Course Management Manual**.

Registration developed and implemented the **Awarding of Military Credit** policy and procedure so veterans can be
evaluated to receive college credit from their military transcript.

Registration collaborated with other Student Services departments to enhance the **Veterans Support web page**.

Staff successfully identified, processed, and certified 150 completers for 2015-16 **who earned a certificate or a degree** but did not submit a Graduation Application.

**Seven DTA/MRPs were awarded in 2015-16** (one Associate in Business and six in Associates in Pre-Nursing), compared to one awarded for 2014-15.



Workforce Funding and Student Support hired a **VISTA AmeriCorp** person to develop a strategic plan to improve student access to and management of financial aid resources.

BTC contracted with the **Employment Security Department** for onsite support of students receiving unemployment insurance.

BTC implemented additional funding support for **DREAMer** (undocumented) students.

Workforce Funding staff actively participated in the implementation of the new **Workforce Innovation and Opportunity Act**.

#### **Financial Aid**

This year, the federal government will begin taking **FAFSAs** in October instead of January, allowing students to use tax information from a prior year to ensure that it will be complete before FAFSA submission.

In collaboration with the BTC Foundation, **BTC disseminated 444 \$500**New Student Admissions Scholarships over the past year.

Financial Aid continued to **improve student communications** regarding dropping for non-payment and no-shows to reduce the number of these instances.

**Staff continued to improve efficiencies** in the financial aid awarding process to reduce turnaround time for students.

**Accessibility** of the financial aid handbook for students was improved.

The BTC loan default rate dropped from **24.3%** in 2014 to **16.9%** in 2015.

Staff worked with Workforce Funding, the Foundation, and the ASBTC Executive Team to refine the **Urgent Funding Team** process that provides student emergency funding and financial literacy support.

## **Instruction** Updates

#### What's new in BTC's programs?

BTC developed its first **Bachelor of Applied Science degree in Operations Management.** It was approved by the SBCTC and by the NWCCU, and the first students will enroll in Fall 2016.

Our second BAS degree in **Engineering Technology** has been approved by SBCTC and is awaiting approval from NWCCU.

Under an NSF grant, BTC completed a **Clean Energy AAS-T degree**, which articulates directly to the WWU Institute of Energy Studies. The degree will launch in Fall 2016.

**The Composites AAS and AAS-T degrees** launched in Fall 2015, sharing a newly revitalized and upgraded joint Composites lab with WWU at the Technology Development Center.

The Engineering Technology "umbrella" reorganization was completed: The Engineering Technology Program now includes six areas of specialization: **Civil, Geomatics, Mechanical Design, Composites, Electronics, and Clean Energy**.

New courses in **physics** and **calculus 3** were offered for the first time.

### **Instruction** Updates

#### **BTC** in the Community

**Dental Hygiene instructor Christine Harwood** went to Jamaica with her students in mid-September to do free dental work on local residents who don't have access to quality dental care. Students also taught local children the importance of dental health and hygiene. Also, on Feb. 6, the dental hygiene students and faculty held a **free dental clinic for BTC student veterans**, supported with funds from the foundation.

**Tracy Bailey, tenured Rad Tech faculty,** was elected President-Elect for the Washington Society of Radiologic Technology, a three-year commitment with the first year as president elect, the second year as president and the third year as Chairman of the Board. Heather Wallace, Rad Tech adjunct faculty, was elected as Secretary/Treasurer, which is a one-year commitment.





### **College Readiness**

**The Transitional Studies department** acquired a **\$36,000** grant to serve Limited English Proficiency (WorkFirst ESL) students.

**IMPACT! Youth Re-engagement program** had over **90 GED graduates** in its first full year. The program serves Whatcom County youth who have dropped out of high school.

# **Awards & Recognitions** 2015–2016

**The Culinary Knowledge Bowl Team** received a Gold Medal at a competition in Hawaii in April 2016.

A team of first-year **Process Technology** students placed in the top eight in the nation at this year's Process Troubleshooting Skills in Energy Competition. The team was one of 25 that competed in qualifying rounds, and took sixth place at finals in Texas this spring.

**Diesel Technology instructor Jeff Curtis** was presented with the Educator of the Year award at this year's Vision Hi-Tech Training and Expo, held in March 2016 in Kansas. Jeff Curtis also took his students on an annual exchange with Rybners College in Denmark.

**The Industrial Maintenance & Mechatronics program** was awarded a \$150,000 Workforce Development Special Projects grant to purchase robots and become a FANUC training center.

**The Culinary program** received an exemplary status with no recommendations on its American Culinary Federation Accreditation. The next accreditation cycle is seven years, the longest offered.

**The Veterinary Technician program** is now fully accredited with the American Veterinary Medical Association.
