## **Apply for Admission to an LPN-RN Nursing Program Cohort**

## **LPN-RN Nursing Program Option Admissions Process**

Students who are program-ready may submit an LPN-RN application during the core program admissions application window. The application window for this program opens in January and will remain open through the summer. The first sorting of seat offers will happen in April and a second sorting of seat offers will happen in July. Complete applications will be added to the Annual Program-Ready Waitlist in the date/time order in which they are received and based on the point system. It is important that applicants keep their contact information, especially preferred email, updated with the college. On the first day of the spring quarter, the waitlist will be cleared and the applicants not selected for that academic year will need to reapply once the next academic year's Application Window opens.

## **How to Apply**

- **1.** All applicants to the BTC LPN-RN Program Option must be **Program-Ready** before they can apply. <u>Students are Program-Ready once they have completed the following:</u>
  - o Current BTC application on file with Nursing as the program of intent.
  - Complete all prerequisite foundational courses with required minimum grades and number of credits.
     Including 30 credits of Practical Nursing, only required for students who completed Practical Nursing education at a college other than BTC. Transcript evaluation process for all courses must be complete.
     Please note that it takes 6-8 weeks to process transcripts once they arrive at BTC.
  - Students are encouraged to conduct a self-audit before submitting their application to their intended program. These <u>Self-Audit Instructions</u> serve as a guide to ensure they meet all requirements and are fully prepared to apply.
  - o Active and unencumbered WA State LPN license.
- 2. Application will be date/time stamped when received by Nursing Program staff.

#### Points system

- Each complete application earns 1 point for each of the following criteria:
- Successful completion (minimum grade met) of 15 or more credits of nursing prerequisite courses at BTC (does not include program/certificate credits; repeated courses only count once)
- Successful completion (minimum grade met) of 30 or more credits of nursing prerequisite courses at BTC (does not include program/certificate credits; repeated courses only count once)
- Successful completion of an Allied Health degree or certificate program at BTC
- Applied last academic year with a complete application
- Applied the last 2 consecutive years with a complete application

#### **Awarding Cohort Seats**

- Applicants will be notified by email within ten business days of submitting their application whether the application is deemed complete.
- Only Program Ready students with complete applications will be added to the Annual Program-Ready Waitlist.

  enough applicants on the Annual Program-Ready Waitlist. The next possible cohort start date is located on
