

# Radiologic Technology Admissions Process FAQ

1. Where can I find information about the BTC Radiologic Technology Program admissions process?
  - The Admissions Checklist located on the [BTC Radiologic Technology website](#) outlines the admissions requirements and process.
2. When are applications accepted?
  - Applications are only accepted during the Application Window. The Application Window generally opens each January with the current year's dates posted on the [BTC Radiologic Technology website](#).
3. How do I submit my application to the BTC Radiologic Technology Program?
  - A link to the online application will be posted on the [Radiologic Technology website](#) when the Application Window opens.
4. Will I need to upload any documents?
  - No. Applicants will not need to upload any documents. The online application is a form that students fill out online from any location and is mobile-friendly.
5. Is it true that the BTC Radiologic Technology Program admissions process includes ranking applicants?
  - Yes. Points will be awarded for number of credits of Radiologic Technology foundational prerequisite courses successfully taken at BTC and for having applied previously with a complete application.
6. Does BTC rank applicants by grade point average or previous degree?
  - No. BTC does not rank applicants by their overall GPA or whether or not they have a previous degree.
7. Does BTC offer veteran students an additional point on the application?
  - No. While BTC does allow veterans early course registration, this does not apply to the Radiologic Technology Program which uses an application process.
8. If I have never taken any classes at BTC, will I still be able to apply to the Radiologic Technology Program?
  - Yes. While the majority of cohort seats will be offered to those who applied first and took classes at BTC, some cohort seats may be available for those who have not.
9. If I will not be done with my foundational (prerequisite) coursework before the Application Window opens (for example I take my last course during spring quarter), should I wait until the next year to apply to the program?
  - Yes. All applicants must be fully *Program-Ready* before they can apply. Program ready means all foundational courses have been completed, the Guided Self Placement process has been done, and, if needed, transcript evaluations have been finalized.
10. Does my official transcript evaluation have to be complete before I submit my application?
  - Yes, if you have taken courses at another college. Visit the [BTC Future Students website](#) for details. Plan ahead as it can take BTC ten business days to evaluate your transcripts and additional time for the sending school to process your request. **All transcripts must be submitted by the deadline posted on the [BTC Radiologic Technology website](#).**
11. Do my general education prerequisite (example: BIOL& 242) courses "expire"?
  - No. General education courses are accepted no matter when they were completed as long as they meet the transfer course requirements.
12. Is it true ATI TEAS are no longer required?
  - Yes, as of April 12, 2023 ATI TEAS testing is no longer required for the Rad Tech program

13. What does the program waitlist mean?
- The program waitlist for Radiologic Technology is a limited waitlist because it is only maintained for one academic year. At the end of that academic year, the waitlist is closed and cleared. Applicants not awarded seats will need to reapply during the next year's Application Window.
14. Can I know where I'm at on the program waitlist?
- No. We are unable to disclose waitlist information to applicants.
15. The program has a BTC cohort and an Everett (EvCC) cohort, can I choose which cohort I am placed in?
- No. Applicants will be able to indicate their cohort **preference** in the online application, but they are not guaranteed to be offered a seat in their preferred cohort.
16. Can I defer my enrollment if I am offered a seat in my non-preferred cohort?
- No. Applicants may only accept or decline a seat offer. If an applicant declines, that seat will be offered to the first applicant on the wait list.
17. Is there any option for me if I cannot accept the seat in the cohort (BTC or EvCC) I'm offered?
- Yes. If declining a seat in one cohort, applicants may ask to be placed at the bottom of the alternate list in hopes of a seat in the other cohort opening up and their name being next on the list.
18. Is the COVID-19 vaccine required for BTC Radiologic Technology Clinical placement?
- Yes. Students will be required to obtain a yearly COVID-19 vaccine during the respiratory illness season, similar to the flu vaccine. Proof of vaccination must indicate that it is for the current season, including the date of vaccination, and the practitioner/location where the vaccine was administered.
19. Are any COVID-19 vaccine exemptions accepted by the program?
- Yes, exemptions are accepted in place of yearly COVID-19 vaccination. Contact [clinicalinfo@btc.edu](mailto:clinicalinfo@btc.edu) for information about exemptions.
